<b>DATA PROCESSED FOR THE PURPOSE OF OPERATION OF THE SITE</b>	The IP addresses or domain names of computers used by users that connect to the Site, the addresses in notation URI (Uniform Resource Identifier) of requested resources, the time of the visit, other parameters related to the operating system and to the environment of the user, information related to the user's behavior on the Site, to the pages that have been visited or searched. The use of personal data is reduced at the minimum in order to limit the treatment of personal data that allow to identify it only in case of necessity or at the request of the authorities and the police forces (for example as for data related to the traffic and to its permanence on the Site or the its address IP) or for the centralization of responsibility in case of hypothetical computer crimes to damage of the Site.
